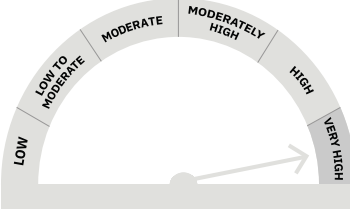
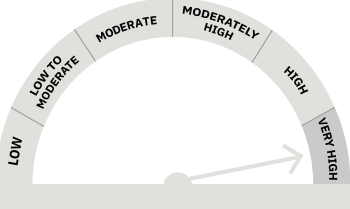

The index is designed to measure the performance of 100 largest and liquid midcap companies from the Nifty Midcap 150 Index.

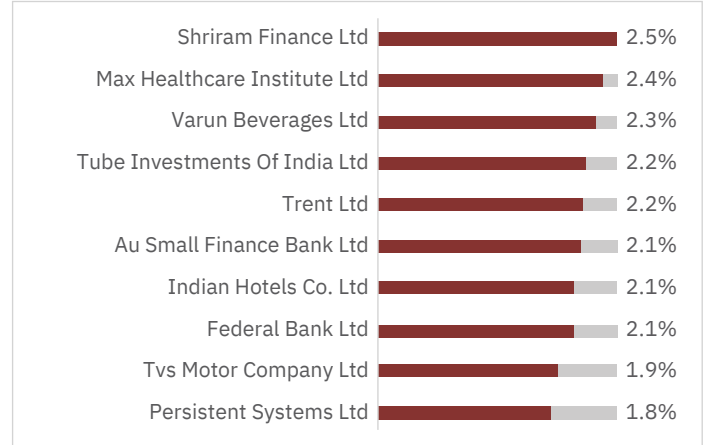

## Index: Top 5 Sectors



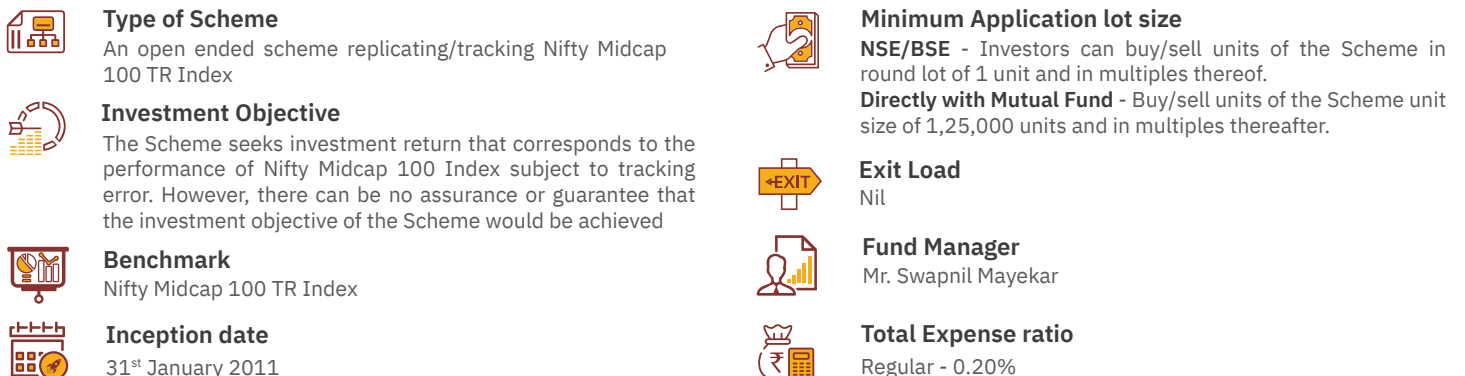
