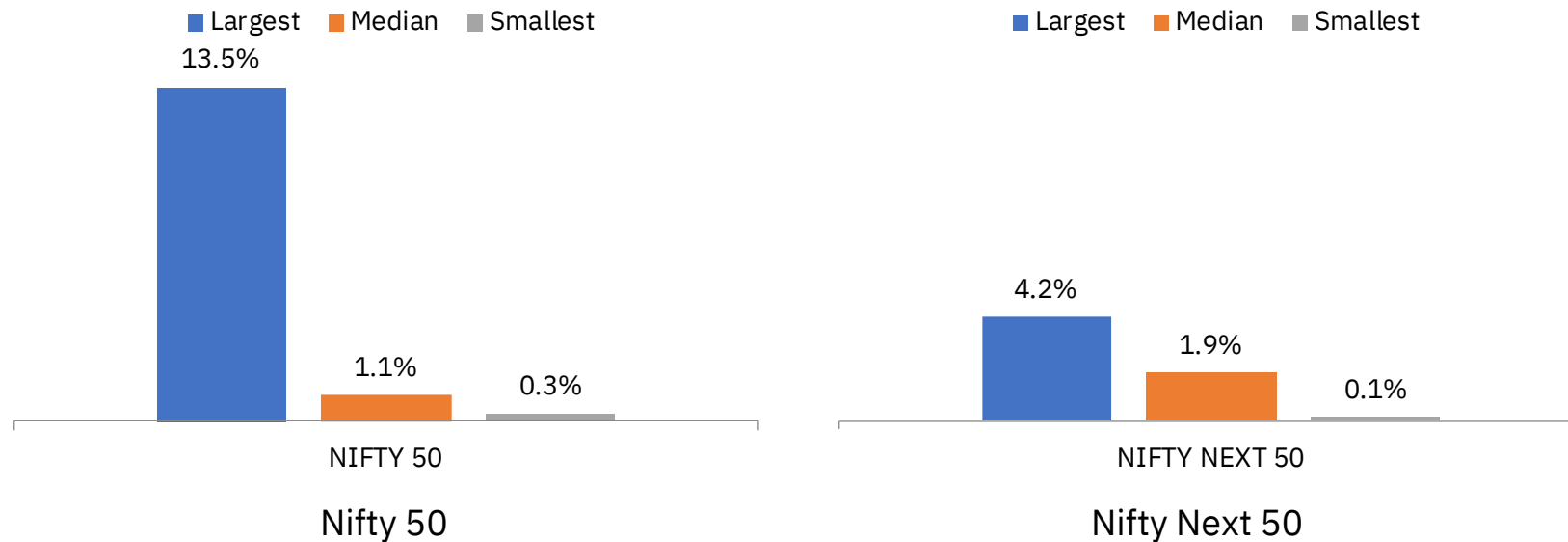

Nifty Next 50 offers relatively balanced representation within its constituents

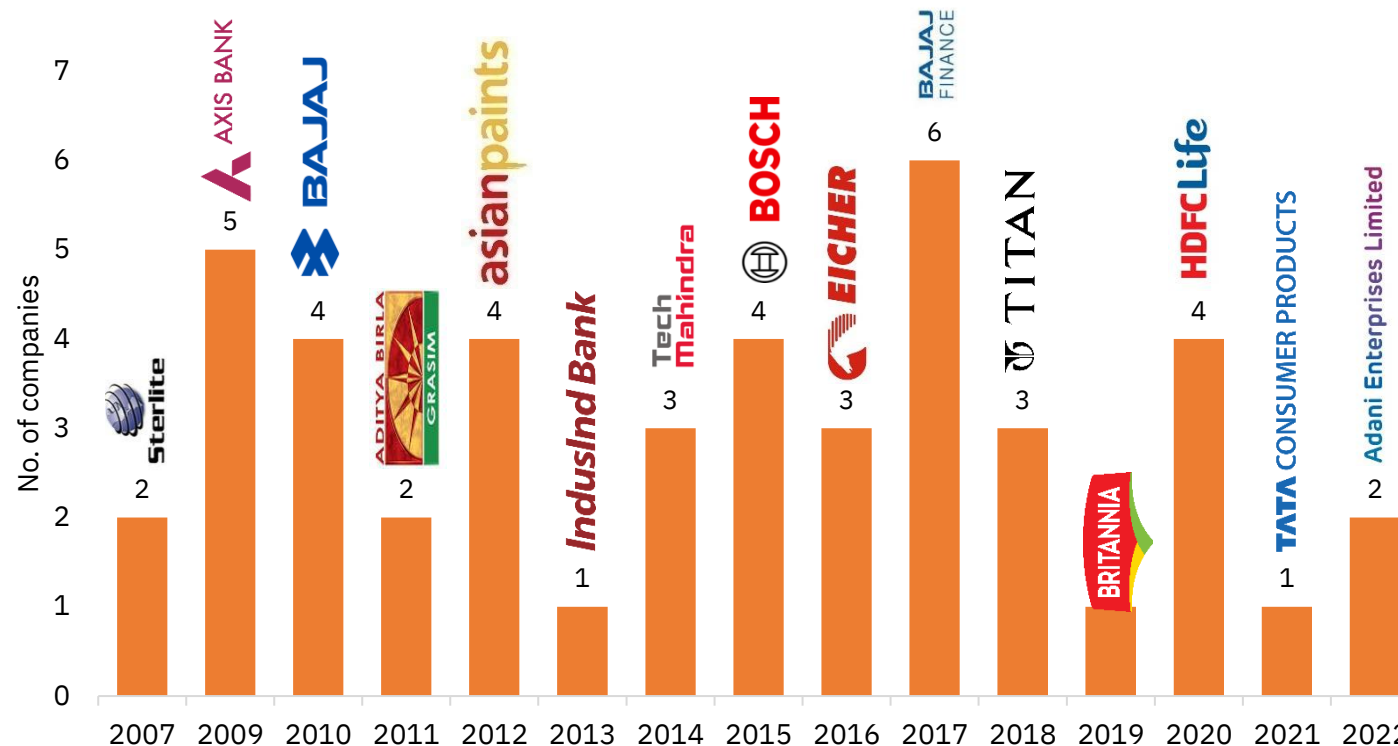

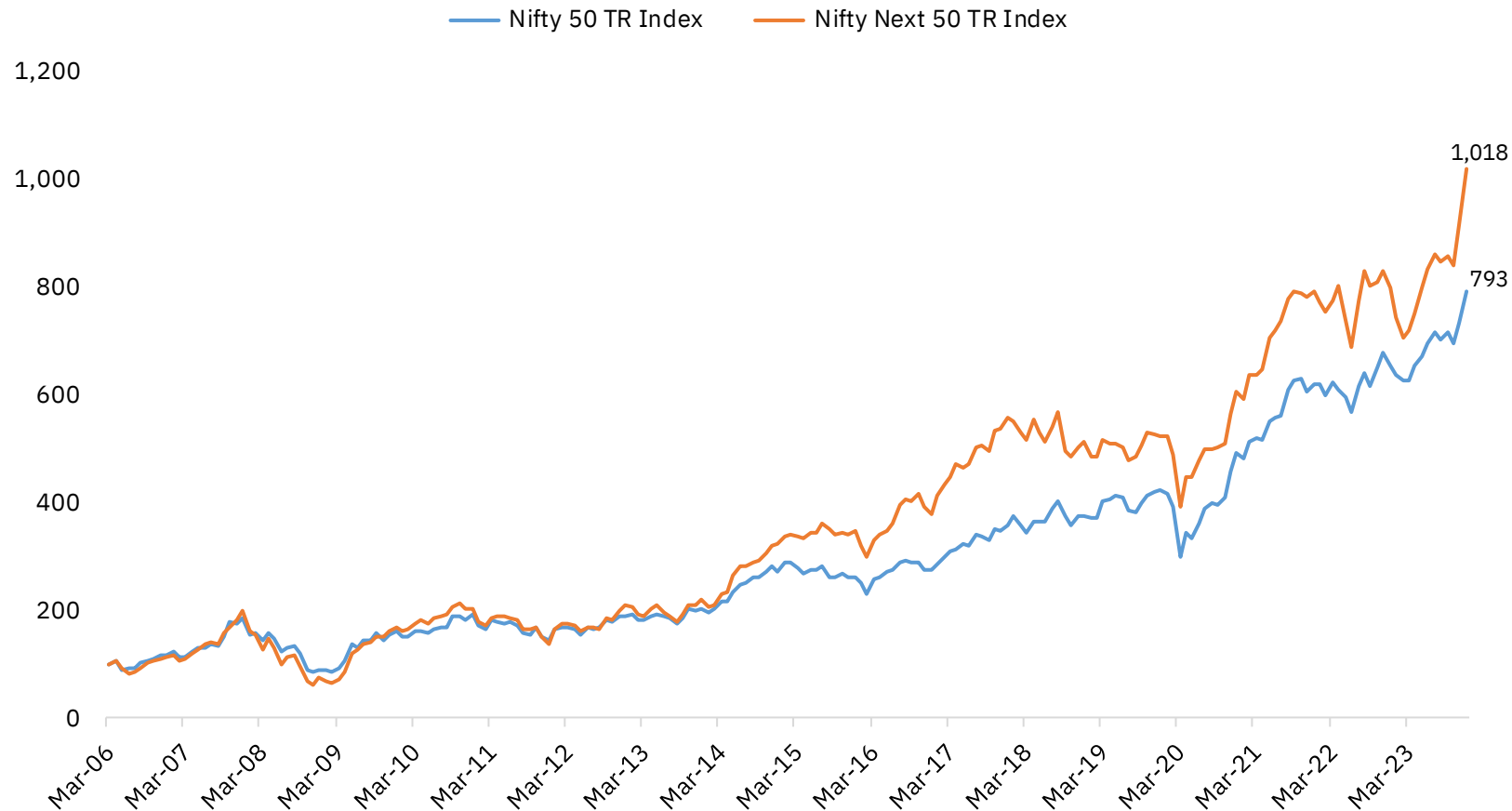
Whenever new companies graduate to Nifty 50, they are usually selected from the Nifty Next 50

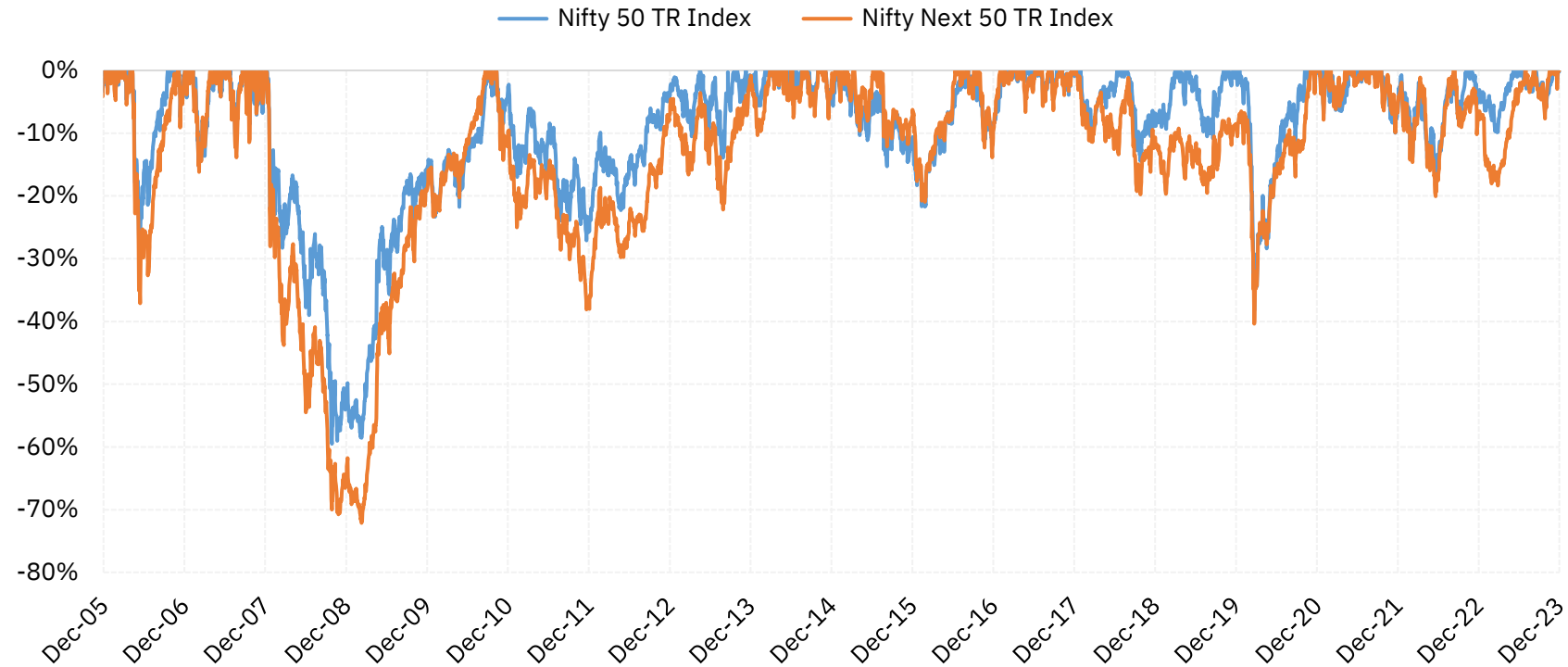

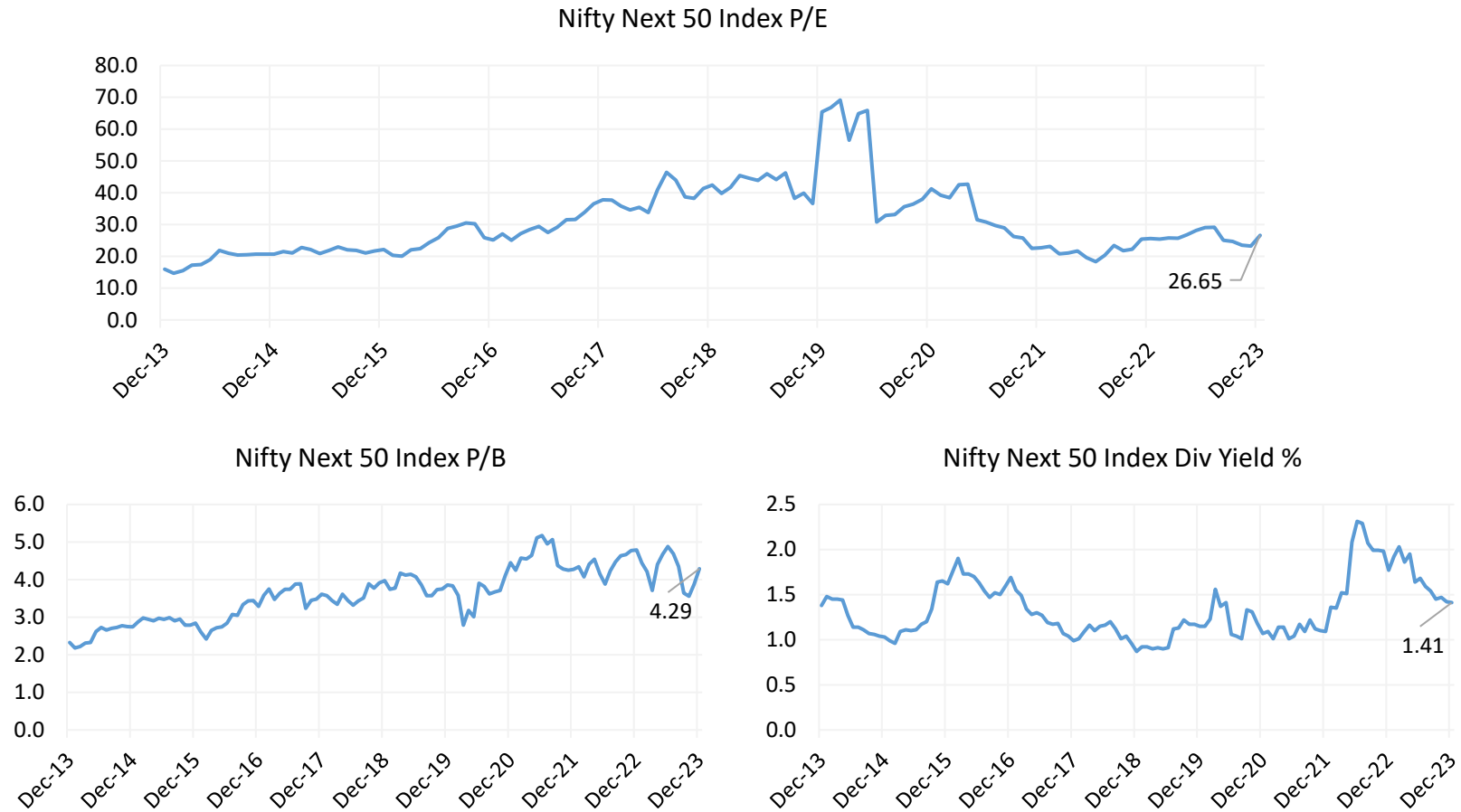
Drawdowns
