



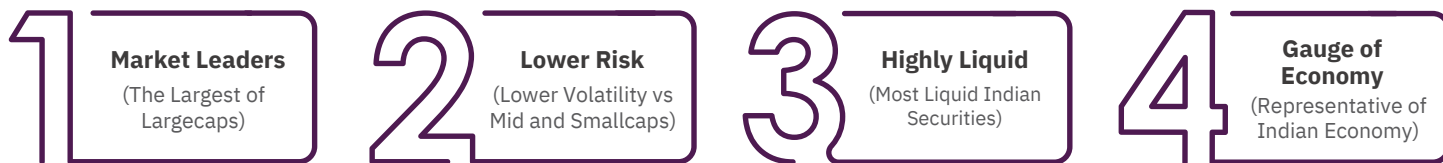

The Nifty 50 Index is designed to measure the performance of 50 largest and most liquid blue-chip companies.

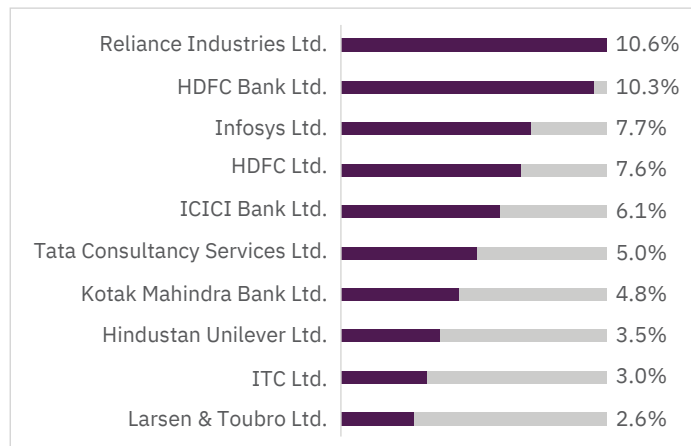
