As you may be aware, due to ongoing restrictions of investments in overseas securities by Mutual Funds, we had to stop fresh subscriptions and pause systematic investment plans in all our International Funds vide the last Notice cum addendum dated March 22, 2022.

AMFI via its email intimation dated June 20, 2022 has allowed AMCs to restart the subscriptions if any limit is available due to redemptions in past few months.

In this regards, we would like to inform that we have not had major redemptions in past few months since this restrictions were applied, resulting in no additional room for accepting fresh investment in any of our International Funds.

Consequently we are continuing with the restrictions on fresh subscriptions and pause on systematic investment plans for following schemes.

- Motilal Oswal NASDAQ Q 50 ETF
